leads advocacy efforts and guides legislative and administrative advocacy on legal and regulatory issues impacting hospitals and health systems. Matthew presented an overview of the top 2022 member concerns – no small list – taking a deeper dive into Reimbursement & Coverage, Health Care Workforce, and Long-Term Care.

Reimbursement & Coverage Wisconsin's population is aging. Many are moving to Medicare which reimburses approximately

73% of health care cost on average. Furthermore, inflation is increasing the cost of providing care. These conditions have focused WHAs work and collaborations closely with members, to:

- Ensure the WHA-created Medicaid Disproportionate Share Hospital (DSH) program remains permanent – which will continue to provide \$130 million annually in payment increases to 90 WI hospitals.
- Protect the WHA-created Rural Critical Care program which provides \$5 million annually to Wisconsin's 28 Critical Access Hospitals that cannot qualify for DSH.
- Fight in Washington:
 - For ongoing federal COVID-related support through CARES and ARPA.

- Big Pharma to protect the 340B drug program a Critical program that many Wisconsin hospital and health system members qualify for, saving \$700-\$800 million annually in drug costs.
- A growing laundry list of insurance company practices, White Bagging, Prior Authorization and Utilization Review abuse, delaying payments and retroactively denying payments, And many others...

Long-Term Care

Over 1600 Wisconsin nursing home beds closed during pandemic. WHA is offering input for a Baker Tilly study looking at the:

- Root-causes of challenges in the cost and reimbursement structures, labor shortages, operational impediments, and meeting federal and state quality assurance standards.
- Prospective analysis to forecast the future state of the long-term care industry to determine consumers' preferences for long-term care in the next five to ten years, and whether Wisconsin's LTC industry is positioned to meet these needs.



• Development of a set of recommendations for both the public and private sector to position the LTC industry as strongly as possible for the future.
